



Transportation Chair – Jacob Gran









Volunteer Chair – Alex Fiks

Portland, Oregon - A Biography

It has not been difficult for Portland, with its enviable network of bike paths, bridges, hiking trails and clear, clean waterways, to find the cutting edge in progressive sustainability. Today, the city on the banks of the Willamette River has simply followed the path cleared, but not clear cut, by the settlers who established the Rose City in 1843.

Residents are easy going -- the name of Portland was chosen in a coin toss -- and they have made Portland a hub of forward thinking. With unbridled creativity, amazing cuisine, progressive politics, cutting-edge music, natural beauty, educated people, and healthy living ... it is a dream city surrounded by practical reality.



Portland is situated 70 miles from the Pacific Ocean, at the confluence of the Columbia and Willamette rivers. It is a majestic place to live, learn, raise a family, work, and most importantly, visit. With clean, timely, and efficient mass transit that includes light rail, streetcars and buses, Portland's historic old town, numerous and diverse commercial and residential districts, galleries and museums, Saturday Market and Waterfront Park are within a few stops in the Free-Rail Zone. The city is also conveniently equidistant from the spectacular Columbia Gorge, Multnomah Falls, windsurfing on Hood River, skiing on Mt. Hood, fish watching at Bonneville Dam, and the splendor of the Oregon coast!



Institutions such as the Bureau of Planning and Sustainability and the Portland Sustainability Institute actively engage the Portland community in sustainability initiatives. From building EcoDistricts focused on sustainable urban living to providing residents multiple ways to recycle at home and work that include composting. And as of October 2011 the city of Portland banned single-use plastic bags in large retails stores.



About Portland State University



Starting out with only 220 students in the city of Vanport, a city along the Columbia River. The originally named Vanport Extension Center was a two-year college program built to meet the education needs of GIs returning home from WWII. After suffering a flood in 1948 and being forced to move three times; the institution moved to its current iconic location on the South Park Blocks in 1952. In recognition of its quality and tenacity, the Oregon Legislature granted it a four-year college status in 1955. For the new Portland

State College, this was the first spark in an explosion of growth—in programs, faculty, and students—leading to full university status in 1969. Portland State University is now an urban research university encompassing 50 city blocks, eight divisions, 226 degree programs, 29,000 students, including 1,700 international students from 91 countries, and 126,000 alumni.

PSU has made a commitment to sustainability and it has shown through various mediums on campus. Perhaps one of the most visible ways that PSU shows its commitment to all things green is through its recycling and composting programs. Part of the university's Institute for Sustainable Solutions, PSU Recycles is leading the way on campus by heading projects such as the campus ReUse Room, Chuck-It for Charity and PSU Office Green Teams.



Recycling is not the only thing sustainable about PSU.

One of our largest sustainable initiatives is our eight LEED Certified Buildings on campus. Two of these buildings are Residence Halls. As the University continues to build and restore buildings they are making sure that they are LEED Certified.

Portland State's newest sustainable initiative on campus is Electric Avenue. Based in the heart of campus, this block of campus offers students, faculty and downtown employees the chance to charge your electric vehicle at one of seven plug-in charging stations.





Residence Hall Association

The Residence Hall Association (RHA) is the governing body representing resident students of Portland State University. RHA is the voice of the PSU residents within the residence halls. Meanwhile the Viking Chapter of the National Residence Hall Honorary (NRHH) is dedicated to recognizing students making outstanding contributions to the campus community and the residence halls on the local, regional, and national levels.



Programming put on by RHA and NRHH includes various fun and educational activities. With RHA programs like SEaK the Blus, where great food is mixed with alcohol awareness education it's always a winning combo. NRHH does its share of programming as well, with the traditional Turkey Thursday program that benefits residents and student staff that are still on campus for Thanksgiving. This program is in its fourth year and is still going strong.

But programming is not the only thing that RHA and NRHH are known for. RHA is known for their Community Garden; an organic urban garden that allows for almost three dozen residents to be able to tend to their own plot of land. The Community Garden is its sixth year of operation and there is now a waiting list to get a plot. One of the Community Garden's goals is to help teach residents and students that use the garden sustainable practices that will benefit the University, its residents and the Portland community. The PSU RHA and NRHH are excited to help sponsor No Frills 2013: LEEDing Leadership. They know that this conference will give students within their organizations a chance to get more involved on the campus and regional level!

The Residence Hall Association at Portland State University was formed during the 2006-2007 academic year. Since 2008 we have attended nine conferences: four PACURH, four NACURH, and our first No Frills was in 2011. Fall of 2010 we changed our name from Resident's Housing Association to Residence Hall Association to be more inclusive and in line with other university language. RHA has strong ties to residence life, many RHA members become RAs, and many ex-RA's become RHA Executive members. This has worked to our advantage in many cases and has been a great place for students to learn and grow in leadership directly benefiting our residence halls.

Although comparatively young, the RHA at PSU is full of passionate and bold leaders who help lead the way to sustainability and success. Through productive programming and community partnerships, the PSU RHA helps build our community from within.





Theme: LEEDing Leadership

LEED stands for Leadership in Energy and Environmental Design and is maintained by the U.S. Green Building Council. The organization is based on creating and maintaining sustainable solutions to current issues. By incorporating this perspective into leadership, we can find new, attainable ways to become more sustainable leaders - in more ways than being environmentally sustainable. What we are proposing is that the principles outlined by LEED can also be applied to leadership perspectives. We are suggesting that by applying these principles we can create not just a natural environment that is sustainable, but we can create a lifestyle of leadership that is sustainable as well.

Leadership sustainability is not only about leading the way to implementing environmentally sustainable efforts on our campuses, it is about creating a leadership environment that is healthy, maintainable, and that future generations can benefit from. The high turnover rate in leadership positions is an unavoidable fact of higher education, but taking initiatives to combat and minimize the turnover rate, helps keep our leadership healthy both mentally and institutionally.



By addressing issues like burnout and workload we are able to maintain a healthy work environment. Recruiting outside resources and calling upon other leadership organizations to

participate in programming can help minimize the workload, as well as creates a greater sense of community involvement. Further, for the leaders that will come after us, we are instilling a legacy that will not die when one key member leaves. With clear record keeping and documentation, we are ensuring that the leaders for tomorrow can benefit form the hard work we are doing today.

Sustainability is so much more than LEED standards, however, these standards create a structure and framework for a culture of sustainable leadership. The principles outlined by LEED are not only suited for the environment; with these principles applied to leadership, our institutions can be sustainable for our future both environmentally and personally. It is with these ideals that we are excited to be LEEDing the way with Leadership.

Residence Life

The Office of University Housing and Residence Life (UHRL) at PSU is an exciting place to work. This department was taken over from College Housing Northwest just over six years ago, and started off with eight apartment style residence halls in the downtown area. Since the formation of the department we have added two new LEED certified residence halls, bringing our total to ten. We currently house approximately 2,000 students. UHRL is committed to working with students to create and support global communities that provide and inspire academic achievement, civic leadership, personal growth, and social responsibility. UHRL is situated in the division of Enrollment



Management & Student Affairs and is dedicated to creating enriching living learning environments for all students who choose to live on campus.



Campus Public Safety

Given that Portland State University is located in the heart of downtown Portland Oregon, it creates many unique situations specific to non-traditional urban college campuses. Safety for on-campus residents and the general student body population is the number-one priority of our Campus Public Safety Officers. Portland State's Campus Public Safety Office patrols campus 365 days a year, 24 hours a day to ensure that campus remains a safe environment conducive to academic excellence. Campus Public Safety Officers are available at any time to escort individuals if they feel at all unsafe. There are also blue emergency phones that connect you with an emergency operator placed throughout campus. Portland Police Bureau can also be seen patrolling throughout many of the main roads that cut through PSU's campus. Both departments patrol all areas around the on campus University Place Hotel, where conference attendees will be staying while visiting Portland State University.



Risk Management

Our campus has a risk management team that aims, "to reduce the adverse effects of accidental loss to individuals and to protect the assets of Portland State University while continually helping to improve: excellence in student learning, innovative research and community engagement." The goal of our risk management team will be in full swing during the conference, ensuring the safety of delegates. We will have conference staff placed in various places along the way from board meetings back to the hotel to ensure that people do not get lost. The conference staff will also be working closely with Campus Public Safety Officers to make sure that everyone is getting safely to and from different events.



Sustainability

Portland State University goes to extreme measures to ensure that we are practicing sustainability, whether that be hosting recycling programs or teaching students how to properly compost food waist. A slogan we live by here at PSU is, "We can't predict the future, but we can help design a better one." This is done in the classroom, our city, our watersheds and our ever-changing world. At PSU students have the opportunity to pull up their sleeves and dive hands first, into volunteer opportunities that both educate and give back to the community.

Technology

ZipCar has agreed to donate two passenger vans the weekend of the conference. These vans will have multiple purposes and the donation will save on registration fees. As stated in the Dining section, Chipotle will be sponsoring a lunch (and will offer vegan, vegetarian, Kosher, and Halal options – otherwise will

be substituted by the Conference staff).

Philanthropy

Sustainability is at the heart of this conference as well as our school. With this in mind, we are asking all of our delegations to be mindful about being sustainable both environmentally and fiscally. We have included carbon emissions for your travel, and we challenge each of the delegations attending this conference to keep the environmental impact of their travel low. - b. If the host school's financial process requires use of an on campus account in order to use the host school's tax exempt status, then the conference staff shall use an on campus account for all conference finances.
- c. The host school shall provide a W-9 Request for Taxpayer Identification Number and Certificate form to any conference participant if requested.

2. Conference Deficit

Should a conference deficit be incurred, the host school shall pay the first \$500 of the deficit. The remaining amount of the deficit shall be paid accordingly: 50 percent by the host school and 50 percent by the regional affiliate. With the noted exception of the following: in the event that the host school does not follow national and/or regional conference budget monitoring policies, as defined by the NACURH/Regional governing documents, the host school will be responsible for 100 percent of any debt incurred by the conference.

3. Regional Organization Fee (Add On Fee)

A minimum of \$ 10 per registered delegate is to be included as a line item of the Conference Budget. This will be considered as the Add On Fee. A check for the final total (fee listed in shaded area, multiplied by the amount of registered delegates in attendance) must be paid to the regional organization prior to the last day of the regional conference.

4. Conference Excess

Any financial excess generated by the conference is the property of the regional organization and must be paid no later than ninety (90) days after the end of the conference.

5. Closing of the Conference - Financial Transactions





The host school must assume the responsibility of concluding all financial transactions associated with the conference no later than ninety (90) days following the end of the conference using funds generated from the conference fees. After this time the host school shall assume responsibility for any additional expenses incurred by the conference.

6. Closing the Conference - General Items

- a. The host school agrees to repay the conference loan (if this exists on a regional level and is requested from and provided by the regional organization) before the last day of the regional conference.
- b. The following additional items shall be submitted to the Regional Director, the Associate Director for Finance, the Regional Advisor and the CRC no later than ninety (90) days after the end of the conference:
 - ☐ A complete financial report for the conference;
 - ☐ The final conference report (guidelines noted in NACURH/Regional Policy Book)

7. Housing Office Responsibility

The Housing Office at the host school agrees to ensure that the host institution has liability insurance, which covers the conference. A copy of the insurance policy or a notarized letter stating the institution's liability (or certificate of insurance) must be received by the CRC <u>no later than 1 month after winning the bid to host the conference</u>. The Housing Office further realizes that the regional organization confers the right to host the conference on the school, not any one individual in charge of the bid process, thereby agreeing to support the conference regardless of change in student or staff personnel.

8. Review of the Policies Governing the Conference

All policies regarding the conference must be followed by the host school. Refer to NACURH/Regional Policy Book for more detailed conference policies.

We have read and understand the aforementioned responsibilities of the conference host school and affirm that if our school is selected as the host for the conference, to the best of our ability these responsibilities shall be fulfilled.
